Torchlight will provide additional in-kind services in the amount of \$5,843; Mentor EVSD will provide in-kind services in the amount of \$4,163.
- Scripps National Spelling Bee, Inc will organize and endorse a spelling bee program in Ashtabula, Geauga and Lake Counties in 2023-2024. ESCWR will pay Scripps National Spelling Bee, Inc, \$4,000.00 from the Extended Learning Grant.
